

Nancy McWilliams, PhD, ABPP, teaches in the Graduate School of Applied and Professional Psychology at Rutgers, The State University of New Jersey, and has a private practice in Flemington, New Jersey. She is a former president of the Division of Psychoanalysis (39) of the American Psychological Association and is on the editorial board of Psychoanalytic Psychology. Dr. McWilliams' books have been translated into 14 languages, and she has lectured widely both nationally and internationally. She is a recipient of honors including the Rosalee Weiss Award for contributions to practice from the Division of Independent Practitioners of the American Psychological Association; Honorary Membership in the American Psychoanalytic Association; and the Robert S. Wallerstein Visiting Scholar Lectureship in Psychotherapy and Psychoanalysis at the University of California, San Francisco. Simply put, this book helps the clinician understand how treatment should proceed with different types of clients. With what type of client is self-disclosure contraindicated? When should one be hyperattentive to boundaries and when should one be more lax? When is a client's adversarial and selfish behavior in session a good thing? With which clients should interpretation be minimized? With whom is detailed, linear "left-brain" thinking complementary and helpful, and with whom is it counterproductive? The book links personality with treatment planning in an easily understandable and highly readable way.

Dr McWilliams is in a class by herself when it comes to psychoanalytic diagnosis. Required reading for many Masters level and Doctoral level students, it is an amazing addition to the library of any clinician, no matter how experienced.

In a time where the DSM, version whatever, has become the diagnostic equivalent of scripture, Nancy McWilliams offers a book that bases diagnoses on understanding the individual rather than a collection of odds-and-ends symptoms. Mental health practitioners may always be bound by the DSM in working with insurance companies, but the ideas presented in this book will provide a much deeper understanding of what guides many of the surface-level symptoms. McWilliam's writing is

clear and concise, simple enough for the beginner but addressing issues of the complexity of diagnoses appropriate for the practiced clinician. This is not a one-time read -- if you have read it once, you will find yourself returning to it many times again.

Not only is it practically a meta-analysis of psychoanalytic literature from her thorough assimilation of all the best books of all time - it reads well! Ever try to read Kernberg, or Kohut? - absolute tedium, but McWilliams makes extremely complex concepts palatable, illustrates them with client stories, and reminds you why everyone needs a foundation in these concepts when trying to understand clients. Note: It's dense, be prepared to read it many times over.

This is a great book for a beginning clinician or those unfamiliar with psychodynamics. It is clear and concise, she explains each idea clearly, while providing a basic history and different points of view on it. It is structured beautifully, very very accessible. I like the summaries and reading suggestions she provides. In all, one will get an excellent idea into diagnosis, regardless of their theoretical orientation. Also, this book helps one understand basic terms such as 'ego states' etc which we encounter in other psychotherapeutic literature but do not get. It is simply an excellent text and I think every clinician should read it. Its really improved my understanding and aided my work.

And this book would be equally precious gift as well as for psychiatric interns and residents as for their psychiatric teachers. Even for the teacher from somewhat different than the author, psychiatric and psychoanalytical traditions, it would be not at all difficult to add their specific vistas among these guidelines. Especially, as the author herself is generous enough to finish her every chapter with "suggestions for further reading".

Dr. Mc William's Psychoanalytic Diagnosis provides a solid foundation for case conceptualization. Enjoyable read for those interested in the field of psychology. I find myself very intrigued by her

analysis. She covers each chapter in a way that demonstrates her abilities to succinctly empathize with individuals I haven't seen any other practitioners quite capture in writing the essence of psychoanalysis like she has. A classic must have!
