

Dr. Davis continues to teach doctor of physical therapy (DPT) students at the University of Miami Miller School of Medicine as volunteer faculty. She is an international invited lecturer on the structure and function of fascia. She has published several research articles in peer-reviewed journals and is the author of 18 book chapters. She served 6 years as a commissioner on the Commission on Accreditation for Physical Therapy Education and was a team leader and site

visitor. She also served on the Ethics and Judicial Committee for the American Physical Therapy Association (APTA) and was Chair in 2004-2005.
